Objectives and investment policy

The sub-fund aims to generate a long-term absolute return, subject to a balanced level of risk and regardless of the market situation, by mainly investing in company shares (equities) and instruments related to company shares. The sub-fund invests in developed equity markets globally with a Nordic bias.

In order to achieve its objective, the sub-fund applies a combination of strategies in equities and in derivatives markets. The sub-fund may invest its assets in open-ended and closed-ended ETFs. Equity exposure may derive from direct investments in equities, equity derivatives, swaps and convertible securities. The sub-fund may also seek short exposures by using CFD's, equity derivatives, swaps, ETFs, index futures and derivatives instruments. Financial derivative instruments may be used both for investment and hedging purposes.

The sub-fund may seek indirect exposure to market equity indices through investments in financial derivative instruments.

From time to time, the sub-fund may invest in fixed income securities and derivative instruments thereon primarily to manage the sub-fund's cash positions.

The sub-fund will not invest more than 10% of its net assets in units/shares of other UCITS or UCIs.

The currency of the share class is SEK.

Under normal circumstances, you may sell your shares any day on which banks are open for business in Luxembourg and Stockholm, except 24 December.

These shares are distribution shares. Income and capital gains may be distributed.

Recommendation

This sub-fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and reward profile



Which materially relevant risks are not adequately captured by the synthetic risk and reward indicator?

- The sub-fund may use derivatives. Due to their structure, the risk associated with these investment instruments may have a larger impact on the value of the sub-fund, than buying the underlying stock or investment instrument directly.
- Counterparty risk: the risk that a counterpart does not fulfill its obligations to the sub-fund (e.g. not paying an agreed amount or not delivering securities as agreed).
- Concentration risk: the strategy employed by this sub-fund may lead to higher risk and volatility than a more diversified approach.
- Currency risk: the sub-fund may hold some of its investments in currencies other than the sub-fund's reference currency. Thus the value of the sub-fund may rise and fall due to currency movements.
- Operational risk: the risk of loss resulting from e.g. system breakdowns, human errors or from external events.
- The country focus strategy employed by this fund may lead to higher risk and volatility than a more diversified approach.

What does this synthetic risk and reward indicator mean?

- The shares of class ID (SEK) are classified in category 5 because the value of the share may be subject to high variations and consequently the risk of loss and the opportunity of gain may be high.
- The risk category has been determined using the maximum risk limit allowed for this share class. The risk category may not be a reliable indicator of the share class's future risk profile. The risk category shown is not guaranteed and may change over time.
- The seven-category scale is complex, for example 2 is not twice as risky as 1. The gap between 1 and 2 might not be the same as the gap between 5 and 6. A category 1 sub-fund is not a risk-free investment - the risk of losing your money is small, but the chance of making gains is also limited.

Charges

The charges you pay are used to cover the running costs of the sub-fund, including the costs of marketing and distribution of shares. These charges reduce the potential increase in value of an investment in this sub-fund.

The figure of the ongoing charges excludes:

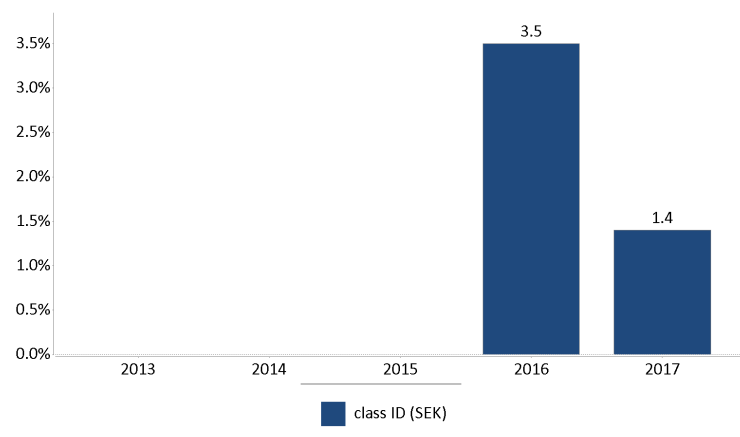
- Performance fee
